

Alaska Artists Guild

The Artist covenants and agrees as follows

- 1. General Conditions:** The Artist warrants and represents that he/she is the sole creator of the work of art signed by him/her and entered in the competition. That the work of art is an original creation and does not infringe upon any other person's copyright or rights of artistic property, nor to his/her knowledge does it violate the rights of privacy of other persons. The Artists agrees to indemnify the Alaska Artists Guild (AAG) and its affiliated partners of this competition, against any final judgment for damages in any lawsuit, out of court settlement or other agreed settlement with any other party based on actual breach of artist's warranties or representations above. In the event of any lawsuit the artist agrees to pay the AAG any costs and attorney fees incurred in defending such a law suit. In the event a lawsuit is brought which may result in the artist having been held to have breached his/her warranties under this agreement, the AAG shall have the right to withhold and place in escrow any sums payable to the artist for works sold by Stephan Fine Arts Gallery or AAG, but in no event may such withholding exceed the damage alleged in the complaint.
- 2. Royalty Payment to Artist:** Stephan Fine Arts Gallery will receive a commission of **40%** and AAG **10%** from sales of ORIGINAL artwork. Artist will be paid **50%** of sales price within 30 days of sale.
- 3. Display and Sale of Original Art:** Best in Show will be used by AAG for promotion and advertising of future shows/contests. **25 prints** will be made to use as AAG limited editions with all proceeds going to AAG for promotion of future shows and education, and will be available at Stephan Fine Arts during the month of April after the show. The April show will be for 1 night only. The Best of Show, Peoples Choice and Stephan Fine Arts selected art will remain and be displayed in Stephan Fine Arts for the entire month of April. All other artwork submitted must be picked up by the artist the same night as the Exhibit. Stephan Fine Arts shall have the exclusive right to sell the paintings for such price as the Artist establishes. Any unsold paintings must be picked up by the Artist at the end of the month of April.
- 4. Ownership of Original Art:** The Artist will retain ownership of the original artwork. If said artwork is sold, the Artist will retain the copyright to the original artwork, subject to the AAG's exclusive reproduction rights to use the paintings as outlined in Paragraph 3 above.
- 5. Termination:** This agreement shall continue in effect for one (1) year from the date of the Final Judging.
- 6. Benefits:** The benefits of this agreement shall inure to the benefit of the heirs, successors, and assigns of the respective parties.
- 7. Loss or Damage:** AAG and Stephan Fine Arts Gallery will not be responsible for loss or damage no matter what the cause. By submitting artwork to this exhibition, each artist will be deemed to have concurred with this agreement.
- 8. Timeline of Event:** Entry deadline is March 22, 2019. Artists may drop off accepted artwork at Stephan Fine Arts Friday, April 5th between noon and 4:00 pm. Show will hang in the Cubby, at the Captain Cook Hotel, from 5:30 -8:30 pm. AAG will award ribbons at night of the show and Artist will be awarded prizes at the end of the show for Best of Show and Peoples Choice.

Criteria for Art: Judges will use a Rubric to evaluate the following; Visual Impact, Interpretation & Creativity, Composition, Design, and Craftsmanship.

7. Late entries accepted depending on # of entries or space availability
